It's just that we're currently in the process of working through our constitution and by-laws for ONCA compliance with D'Agostino and Associates which has resulted in significant changes to the document, and in all likelihood, it may not be totally, it may not be finalized by that date. I'm just wondering in terms of the requirement to submit it, if we could defer that, I mean, we could use the old one, but it's not going to be compliant.

Jason Marchand, NOHA Executive Director: So, what I would suggest is, as of whatever date, whenever you submit your package to Kiersten, provide what is currently approved, and then it's going to be a kind of one-time thing for a lot of groups, so as your membership approves the new By-laws, you can just submit that to us. In the end, this was just intended

Dick Farrow, Moderator: This would allow the NOHA President to vote at Board meetings. It's a two-thirds majority vote, and you can see the rider at the bottom says if passed, motion number ten would become housekeeping. So, does the mover or seconder or anyone from the Board wish to speak to the motion? Mr. Zajac? The microphone, you've got one right here. Just identify yourself.

Ted Zajac, Porcupine Minor Hockey Association: Just a question on this motion, I'm not quite sure, I've been around for a while, the rationale behind it? I know in past, any board, there's never been a tie. The reason for the president and the chairman is to break a tie. Is this is passed, you're going to see a possibility of a four-three vote, and then the president votes, which would make it a four-four tie and that motion is defeated. I believe that the system that's in place right now where the board members vote, the president votes to break the tie, not to create a tie. That's just my thought, I'll be voting against this one, thank you.

Dick Farrow, Moderator: Thanks, Ted. Steve?

Steve Lawrence, NOHA 1st **Vice President:** This came up because there's a provision in ONCA that the president can vote, so as Ted said, usually in our situation, if there was a tie, the president would vote to break the tie, but otherwise wouldn't vote. But now that the president votes, basically if it's a tie, fifty-fifty, the motion's defeated, so [inaudible] it just simply means that if it's fifty-fifty, actually I was just at the meeting for the ALLIANCE, actually, and for the first time we had a fifty-fifty voting motion and the motion was defeated. Sometimes the president has to actually break the vote, I don't know, I haven't seen it happen. It's just because ONCA provides that, so we're just going to try and, you know, go with what we're signing up for with the regulations, with the compliance. Does that answer you, Ted?

Ted Zajac, Porcupine Minor Hockey Association: No. No, Steve, thank you very much, I know with ONCA everything's changing. But my only point is that it's not broken. I think there's nothing worse than an association having a motion and then coming back after the date and asking how'd the motion go? It's a tie. Well, that's like, you know. It shouldn't be a tie. This way is past practice, there's never a tie, so at the end of the day, the motion's

Is that correct? So, we're at the pleasure of the people, here, so whatever you decide, if it's not broke, don't fix it, or maybe some of the newer trenders would let us get on board, but we put it in for ONCA compliance, but we're not out of compliance if we stay either way. At the pleasure of the people ,vote how you feel.

Dick Farrow, Moderator: Okay, any other remarks? Pretty straightforward. So, all those in favour? Those opposed?

At AAA, and U15 and below, where an Association can only field one Team at an age division, the Association shall field the Major Team (i.e. U11, U13, U15, U18).

Rationale:

The NOHA has specific requirements as it relates to Regional Championships, and OHF Championships, which only operate at the Major Divisions. Not having a Major Team, in particular at the AAA Level where there is limited competition, creates many logistical challenges where Leagues no longer meet the definition of a League (3 Teams), creates issues with respect to affiliation and issues in terms of being eligible for Regional Championships. The NOHA did submit a request for a one-time exemption two seasons ago, but we were advised that it would be a one-time exemption. At the Minor divisions, there is more latitude as there is no Regional Championship.

Dick Farrow, Moderator: We'll move on to number 28 now. And this one would require associations to field a Major team before they can field a Minor team at the AAA and U15

and below. The NOHA received a one-time approval for an exemption from the Hockey Canada regulations at AAA where an association could not field a Major team. It creates challenges with respect to affiliation and eligibility for regional championships. Anyone from the Board? Jason's going to speak.

Jason Marchand, NOHA Executive Director: I think what's on the slide explains it fairly well, but those at the AAA level, in particular, may recall a few years ago that we had to get Hockey Canada approval, and it was a one-time thing, we were told that it would be a one-time thing. Hockey Canada has specific requirements with respect to the number of teams in a league and specific rules with respect to teams that are eligible for regional, i.e. OHF or national championships, so U18, Junior A, so this puts the onus to have that major team, where there are those, those championships for which teams are eligible. So that's, in a nutshell, the rationale. Obviously it creates logistical challenges at the association level, but from an overall NOHA league perspective, quite honestly, with the current Hockey Canada Board, we won't be getting any exemptions going forward, they did say it was a one-time approval. The current board is focused on operating under the rules, so not providing those types of, those types of exemptions.

Dick Farrow, Moderator: Thank you, Jason. Any questions with regard to this? All in favour?

Steve Vachon, Timmins Minor Hockey Association: We—I am not in favour of this one, only because let's say you've got a group of kids, they start at U10 AA, they move on to U11 AA, you know, you get one or two players in and out during those years, but then they play U12 together, U13 together, U14 together, so they've been together for a long time. The parents know each other, sponsorships, all that jazz, right? So now, in our city, at U15, there is a AAA team. Right? So it changes the landscape for us. So that U14 team would be forced to have that team separated, and half of them as first-years would go play U15, and perhaps they're not ready, it's their first year of body checking, so for us, it just doesn't work with the way we're set up in Timmins.

Dick Farrow, Moderator: Thanks, Steve.

Steve Vachon, Timmins Minor Hockey Association: Yeah, sorry, we would rather see that group stay together. We understand that TMHA would not have a chance to go to an OHF that particular year, and we're okay with that, they'll have their chance the following year.

Dick Farrow, Moderator: Okay, Jason?

Jason Marchand, NOHA Executive Director: Just to add to that, Steve, and I understand that piece, but depending on what happens, depending on leagues, etc., there is the potential that those kids, if there's not a league to participate in, if, you know, various things happen, they may not be able to affiliate up to a higher division, there's lots of different factors that may come into play if it's only a Minor team, so, and again, this is more AAA level with regional championships, competition against other teams, etc., but those are logistical things that can be issues just so everyone is aware.

Barry McCrory, Northern Ontario Hockey League: Jason, if this passes, so, our division of U12 this year, AAA, will they be considered a division?

Jason Marchand, NOHA Executive Director: You only have two this year?

Barry McCrory, Northern Ontario Hockey League: Two. Right now. So, this, if this passes, we can't have U12 AAA?

Jason Marchand, NOHA Executive Director: So, the teams are already formed, so this is kind of moving onward, more for teams that haven't been formed yet, I know there are some that haven't had their tryouts yet. But the challenge that we are going to have, regardless, is again, it doesn't meet the definition of a league with two teams, so we'll have to navigate that, I think, outside of this—

Barry McCrory, Northern Ontario Hockey League: Don't navigate it, because we have this year—

Jason Marchand, NOHA Executive Director: This won't impact, this rule won't impact, kind of, this year, in terms of the teams already formed. That's a different challenge.

Barry McCrory, Northern Ontario Hockey League: So, Jason, last year, our U14 only had two, and we were told they weren't part of a league. Where's, where's Angel? Do you agree with me on this? We were told later on that they were not part of a league. So, if you people vote for this, I still, I don't understand the rationale because the OHF is doing it, Hockey Canada, you know what I mean? So I totally support Steve on it, like there's teams that are coming up that, sorry. Nothing? It's on. Hello?

Rationale:

Based on the directive from the Membership at the 2023 NOHA Annual General Meeting, a Committee was formed to look at Select programming within the NOHA. The Committee was made up of representatives from Associations as well as from the NOHA Board of Directors. The Committee reviewed current policies across the Province in drafting its own policies.

Moved by: Adam Dunseath, NOHA Executive **Seconded by:** Rick Barron, NOHA Executive

Dick Farrow, Moderator: Okay, we're going to move to number 29 now. Does anyone wish to speak to it from the Board?

Jason Marchand, NOHA Executive Director: This is going to kind of just give the Board some time to work through policies and procedures. The committee was formed and led by Yves Lalonde, we'll save him getting up for his leg, there, but in the end, we had two members from Minor Hockey Associations, there was a member from North Bay Minor Hockey and a member from Timmins Minor Hockey and our Board members who worked through some of the other Select Hockey policies. The Board actually approved the policy yesterday, we just need to put it into a cleaner format, but if this is supported, we're going to follow those policies and procedures. Kind of the high-level highlights is essentially that these teams will be permitted two tournaments with the focus on the main team, obviously. The timing would be kind of December/January for a starting point. In the end, it's two tournaments max. There will be an opportunity for different associations to collaborate to field, to field teams. Not to pick on anyone, but Blind River and Elliot Lake are close, so if they only have one House League team and they can't field two, there would be an opportunity to collaborate together to field a Select team. Select Hockey is for House League teams only, it's not Rep teams. It would start at U11, not U9, U11 up to U18. So, if there are any specific questions, but this would allow Select Hockey to, to operate and we

do have a committee, like I said, and we will continue to be able to evaluate how things have gone.

Tyler Mairs, Porcupine Minor Hockey Association: I think this is a little too fresh. I would like to see the policies before we can make an informed decision on this, right? I mean, right now we're just saying yeah, we're going to let these teams kind of go, you guys have a lot more information on these policies than we do. I think at this point, it's too early, we don't know what the landscape looks like, I think it's going to be hard to make an informed decision on this without knowing what the NOHA has laid out for us.

Steve Vachon, Timmins Minor Hockey Association: We're in favour of this. We draft all of our players, and usually, at every division we have about four different teams, so this allows for the top players on each of those teams to get together, go to one tournament or two tournaments that don't conflict with their regular-season schedule, something special for them. There's been a lot of talk about it in our community, and people are really excited about it, so we're hoping that it will be.

Greg Robinson, Iroquois Falls Minor Hockey Association: At last year's AGM, it was said it would be open to all players, is that correct?

Jason Marchand, NOHA Executive Director: So, in the minutes last year, we provided some clarification, and this was a misinterpretation on my part and others in terms of change at the OHF level, so in the end it is, it's up to the association ultimately how they form those teams, but in the end, Select hockey is in other communities, and all the Select tournaments are in Southern Ontario, so...

Dick Farrow, Moderator: Any other questions or comments with regard to this?

Ted Zajac, Porcupine Minor Hockey Association: Just this motion, I was against this last year when it was passed. I really believe that—this is just my own opinion—I really believe that House League hockey or recreational hockey, the kids now are at a disadvantage. I see it, I was involved in it this year, they don't get enough ice as it is, they don't practice, it's always Saturday morning, Sunday morning at eight o' clock in the morning. By putting in this new category—just—by putting in this new category, my opinion only, it's going to reduce the amount of ice time available for recreational hockey players. Because I know in areas, there's not enough ice in the City of Timmins to—and I was just talking to the City of Timmins—there's not enough ice in the City of Timmins for these kids to develop as it is, because we're only getting one hour of ice time. If you put in more teams, because these

teams are going to want practice time. They're not going to go to tournaments without, so what's going to happen is, a team of twelve hockey players, right after their House League practice, the coaches of the elite hockey system are going to say Johnny, Peter, Paul, and Harry, come on the ice, we're on for elite, and those other six kids are left behind. We already leave House League behind, I just feel this is another avenue where a kid can be left behind, and I really believe that. If kids wants more ice time at House League, they can affiliate to rep teams, he can affiliate and get all the ice time he wants, but to put another group of kids at the House League level, then what you're doing is, in my opinion, you're leaving more kids behind, and they're going to leave the game. Thank you.

Michael Creasey, Copper Cliff Minor Hockey Association: So, I recall at the meeting last year in Timmins, we talked about this, and it was brought up about Selects, and it was said that anyone who wishes to participate in Select Hockey had to have a spot in a Select team to play. So, say in Copper Cliff, I have four U13 House League teams, and all the players on all four of those teams chose to play Select, I have to offer all four teams that position. Is that what would happen? So, I have four teams, and then I have four more teams. It's going to be a mixture of those teams or the same four teams, or whatever.

Jason Marchand, NOHA Executive Director: I answered it in the last question, but in the minutes, we provided a clarification. There was a misinterpretation of the OHF Regulation, so when I spoke up here last year, I didn't have the correct information, so the clarification was provided, so, ultimately, Select Hockey does not, does not have to be for every single person who wants to participate. That's up to Associations when they have people interested, that's their call, but it's not a requirement that is you have fifty, that—

Michael Creasey, Copper Cliff Minor Hockey Association: So, it's a tryout basically.

Jason Marchand, NOHA Executive Director: Yeah.

Michael Creasey, Copper Cliff Minor Hockey Association: Thank you, that was my question.

Steve Lawrence, NOHA 1st Vice President: It's a tryout with no bias, so anyone can put their name forward to tryout.

Nicole Clouthier, Soo Peewee Hockey League: Are we debating whether we're going to run this or not? Because I feel like it was already approved and we're standing up here debating whether or not we're going to run it again. We're just debating right now the policies and procedures, not whether we're running it. I feel like some people are getting up and debating whether we're running it, and so I guess I'm calling a point of order that we're debating things that we shouldn't be debating on.

Steve Vachon, Timmins Minor Hockey Association: That was my same comment. The current constitution says we will have Select once policies and procedures are in place, so if you vote no on this, Select is happening, because policies and procedures are in place. If you vote yes, we're saying we're going to follow the policy.

Dick Farrow, Moderator: Okay, does anyone else need more information?

Kyle Irvine, Iroquois Falls Minor Hockey Association: I think everything is still pretty new, we haven't had time to review the policies and procedures to determine whether this won't work for Timmins, or Copper Cliff or whoever, right, the bigger Associations who can have Select teams, so it's the same kind of idea, the policies and procedures need to be rolled out prior to approving them.

Dick Farrow, Moderator: Jason?

Jason Marchand, NOHA Executive Director: So, just real quick, in the end, the Board is appointed to develop policies and procedures. It's not a, it's not a requirement to share it with people to get their support, they, they've approved the policy, so it's been approved, so in the end, as Nicole said, one way or the other, it's, you okay, using the same wording, and we have a policy that could be in place, or amend the wording, say that we're following it, and we still have a policy and procedure in place, so we will share it, but it's timing-wise, the amount of work involved to look at kind of what's going on and to kind of share it to be best practices, that kind of thing, the amount of work involved was significant. So, and timing for the meeting, as well, we spent yesterday with the Board, so that's a timing issue, but, in the end they were supportive, so in the end there's no change.

Dick Farrow, Moderator: So, okay over here.

So that's just because that's what we have. Now, that policy that's put forward will likely get amended because it's in the very very first form and you know, development, work through it, there's a few tweaks, but we can't put it out there if it's not in the book. So, we're saying let us put it in the book, vote for it, then we can get after it, we can get the feedback in, we can get it out, get it emailed out to everyone. We were charged with putting together the policy, we've come up with it, we're saying it's done, it needs a little bit of shining stuff on it, but it's ready to go, then we can put it in the book. So hopefully that clears everything up.

Dick Farrow, Moderator: Okay.

George Suszter, East Nipissing Minor Hockey Association: So, last year, East Nipissing put in for the amendment, the idea was that the NOHA needed time to get policies and procedures so that we could have Select hockey in the North. So, we voted on the motion and Select hockey teams were approved. And the only motion that we put forward is to allow the NOHA to come up with policies and procedures and move forward so we can defer to this and say that we're now going to have Select team already happened, that happened last year. The NOHA now has policies and procedures there that you can get, that's all we asked them to do. We asked them to bring up some policies and procedures, get an organized committee, and they've done that. Basically, in my mind, we, you know, move forward and allow them to put it into the book. All they're asking, all they're asking from us it to put it into the book, and if that's what we have to do to move forward, that's what we have to do. We asked them to put the policy and procedures into place. I know you guys don't like the policy, but we asked them to do that so maybe they can give us a bit of detail, but that's what we asked.

Dick Farrow, Moderator: Okay, down here we have a question.

Sherry Roberge, Porcupine Minor Hockey Association: I get this was passed last year, I understand, I understand this was passed last year, we're not debating whether we're going to have Select teams or not, but, and I understand in order to do this, and have everybody be able to play on these Select teams, we need a policy and procedures, and I get

Rick Barron, NOHA Executive: Bottom line, if organizations don't want Select hockey, they don't have Select hockey. If organizations want it, then there's an avenue for kids to play. That's what it comes down to.

Steve Lawrence, NOHA 1st Vice President: The policy will be out in a week or so, we're thinking. And it's like Rick said, this isn't for everyone, it isn't mandated for every association. If an association happens to have an appetite, or the people you're at the pleasure of serving have an appetite for Select, there are rules that the province already has established for Select hockey. There are tournaments that are already in place. It was given the opportunity to your association if you want Select. We were charged with coming up with a personal policy for the NOHA so that we can have guidance on how to assemble this, again, it's going to be out to you in a week. Can we get it out to you in a week and get it in the book because without that policy, we can't move forward. Because last year it was voted on that your association wants to—you don't have to have one, but if you do—here are the guidelines and the framework to do it. So, for those who want to have a Select team, it's that if your association decides that a Select team is good for your association this year for House League, you have the framework and guidance to do that. We're going to get it out to you in about a week, that gives you plenty of time to bring it back to your boards and say well this is what it is, and then give us feedback to say hey, can we change this and that? And then we can put that in there. So, it's to start that back and forth, start that ball rolling, and it's not a big ask. I just think somewhere in the communication somebody lost the whole thing. It's not a mandatory thing, it's at the pleasure of your boards to say hey, we want Select, how do we go about that? We'll get that to you in about a week which was tasked, tasked to us last year at the AGM.

- c) Any Senior, Junior or "AAA" member Association/Single Entry Team may suspend its playing activities and apply for a leave of absence with the approval of the NOHA Board of Directors and appropriate League.

A leave of absence shall only be granted for one playing season and must be applied for by May 1st for the following season.

Any Association/Team which is granted a leave of absence and does not reapply by May 1st the following season shall lose its franchise.

Any Junior or "AAA" Association/Team affected by the above regulations and wishing to reapply for entry after more than the one year leave of absence will be treated as a new entry and would have to follow the Regulations, By-

Any Junior or "AAA" Association/Team affected by the above regulations and wishing to reapply for entry after more than the one year leave of absence will be treated as a new entry and would have to follow the Regulations, Bylaws and Policies as covered in the NOHA Constitution and League Constitution.

Dick Farrow, Moderator: It's a 50% motion. Is there someone from the Board who would be speaking to it? Jason?

Jason Marchand, NOHA Executive Director: This ties into a change that the Board made with respect to new teams and requests for new teams so that essentially the Board is not making a decision on a kind of one-year thing, and they want to see that there's a plan to be sustainable, a development plan, and things like that, so we currently have this in for teams that are requesting Leaves of Absences. It's not saying the Board won't approve them coming back from a Leave of Absence, but there is a requirement now to return as opposed to just applying for the team the following year. So, again, it kind of just ties into that, we had to make that adjustment because it's not in the regulation.

Dick Farrow, Moderator: Any questions with regard to the motion, or any discussion? If not, all those in favour? Those opposed? All those in favour? So the motion is Carried 34 to 25.

Michael Creasey, Copper Cliff Minor Hockey Association: Can we recount?

Dick Farrow, Moderator: Sure, we'll do a recount.

Barry McCrory, NOHL AAA: So, people, honestly, this affects a lot of hockey. Some people want to ask some questions on it, and it went real, real fast. Can we go back and have some questions on this?

Dick Farrow, Moderator: Is the floor in favour of that? I know it's delicate and I want to get more—

Barry McCrory, NOHL AAA: Just for AAA hockey, we're sitting her discussing it, and then you call the question on it. We're having a discussion it, like, a lot of people don't understand exactly what's happening. So, basically, North Bay Minor Hockey U12 doesn't have a team this year, AAA, so they have to reapply, and this Board here makes the decision whether they get AAA cards at U12 AAA next year. Is that what you're saying?

Jason Marchand, NOHA Executive Director: So, just to clarify the process, in the end, the Board can approve or deny a Leave of Absence request regardless, so North Bay hasn't officially requested a Leave of Absence, so we haven't dealt with that. It's similar to U15, I think. So, the Board denied that last year, so they had to apply as a new team, which requires them to follow the process that's outlined in here in terms of demonstrating a plan forward, development, sustainability, etc. So in the end, one way or the other, like, if the Board denies it, they go through a new team request, if the board approves it, when they come back, this is approved, they provide that same information so that the Board knows of the plan to ensure that, you know, if that team doesn't operate, you know, the reasons for that team not operating are addressed. That's ultimately the goal, in the end, one way or the other, it doesn't change anything.

Barry McCrory, NOHL AAA: Jason, I just want to, so people know, Tim will back me up on it. They didn't have a U14 team last year in North Bay. The NOHA Board, Jason, you told me we were going to push them to U15 AAA. Tim? I don't want to put anyone on the spot, but it's a delicate situation because U15 boys and girls cannot be forced to play U15 where there's a huge difference. A huge difference.

Tim Lowe, NOHA Executive: So, I think what's lost in this, if I may, is is that, for example, there is no U12 AAA team this year in North Bay. Those kids next year, well, but there is a U13 AAA team, so next year, the U12s will move to U13 no questions asked. Their birth year is affected. The team coming in that is U11 to U12 is nowhere in this mix because their birth year is prior to U12. They're unaffected. So, for us, in my mind, for us to deal with this as a team versus a birth year would be incorrect. So that's what's kind of lost in all of this is that we have a team, and I get the sustainability, but we have a team that doesn't exist, but it's that birth year that doesn't have a team, not a team that doesn't exist. I don't know if that's—

Barry McCrory, NOHL AAA: That's very true, but, like next year, if North Bay Minor Hockey, or North Bay Trappers want to have a U12 AAA team, they have to apply to the Board for that, and hopefully next year there will be a U15 team. I don't understand. You allow U16 teams just to pop up, and Sault Ste. Marie, North Bay this year got U16 cards. Did they go through, did they go through an approval process?

Jason Marchand, NOHA Executive Director: Not, well not this time around, no, but that's what this is saying so we approved, we approved a new team process which is different than what it was before, but any teams that currently exist operate, have operated under the current rules. So, ultimately, this is not, this is about following the same process that we have in place as a policy with respect to new teams. And all the Board is asking through the discussions is, is that the Association provide in writing their plan to ensure that the programs, in general, are sustainable, and I'm not going to pick on any or refer to any specific organization, but in the end, like, generally speaking, for regional programming, like when there's not a team that operates, there's reasons for it, right? So there needs to be from the Board's position an understanding as to how, how that issue, or those issues are being addressed, ultimately, and it's not saying your team doesn't exist next year, I heard that mentioned, that's not what it means. It means the Board is asking the association to demonstrate how they're going to ensure that program is ultimately sustainable.

Barry McCrory, NOHL AAA: So, I'm speaking against this because for the U14 this year, I don't belong to the North Bay Trappers, I was told the U14 wouldn't exist, they had to play U15. It's not just AAA hockey, people. Anybody that takes a Leave of Absence at AA, A, you're going to have to apply to get a team next year, all right? And I understand what you're trying to do, but you shouldn't hold people, do you know what I mean? Whether it's Association, population-based, the free-player movement the last few years has just blown everything out of whack, do you know what I mean? I'm just saying don't support this motion, thank you.

Dick Farrow, Moderator: Steve, just a second, please.

Val Villeneuve, Nickel City Hockey Association: I don't support this motion and our Association doesn't, either. I think it's just another way to take our autonomy away from hockey associations. It's, yes, we can apply for a Leave of Absence and they can deny or approve that, but the process for a new team application is much larger, and there's a lot more things that go into it. So, basically, you have to say yes or not to a Leave of Absence, whereas they can look at all the factors that you're submitting and then decide to not give you that team again. So, like I said, there's already a check and balance in there, they can decide whether they want to give us that Leave of Absence, now they're just making us do a whole bunch more work to prove to them that we can sustain those teams, and who knows better whether your Association can sustain a team than yourself? You know if you can run that team.

Dick Farrow, Moderator: Okay, thank you. Steve?

Steve Lawrence, NOHA 1st Vice President: You said it yourself, imagine a team coming in. The Board gives Stevetopia a AAA team because I've decided we can sustain that. All of a sudden now, tryouts come, I only get seven kids come out. Well, sorry, we're folding. You already have a schedule. You already have all kinds of stuff set up. I put in a willynilly thing and through nepotism because Jay is married to my cousin's aunt's sister, they convinced the Board to give me the team. You see? This type of stuff eliminates any of that stuff, and it gives you a little bit as a League, not just your league, but any league, it just gives a little bit. We want to approve the teams. There's not, there's not one person that sits on here that doesn't want approve a team, we want to approve the teams. [Cross chatter]. If you give that, if you give that information, I know it's tedious, I, myself, have gone up to the Board and sat up here, to ask, hat in hand, can we please have a team? The more information I provided at that, it gave us a better success rate at receiving a team. And we're just the stewards of Hockey Canada, we're just the stewards to follow the rules. Because, obviously, without those strict things, the AAA is the strictest, and as you go down, it gets a little less, a little less, a little less, and then House League, it's because this is such a passionate thing. Every association has so much passion and stuff that we have to be the stewards of reason. And sometimes that hurts Associations' feelings, people's feelings, and everything else, but we have to keep the rudder straight. We can't, you know, so that information we're asking is simple just to well, say, hey listen, well, absolutely, they've got everything in place here. We feel there's going to be success. And then we don't have a league saying holy moly macaroni this is happening again, look what's happening at that 2010, we lost a team, the whole league was in chaos. We think of these things before we come up with this, obviously, it's not just a control issue. We already have the control, whether this is passed or not, your teams still get passed or denied in the same manner. This just gives, in my opinion, and you'll be like, yeah, right Steve, try to sell me another car, in my opinion, the more information you provide, the greater chance that you have of receiving your approvals.

Barry McCrory, NOHL AAA: So, this year, I'm the commissioner of the AAA League. North Bay, we have no schedule drawn. North Bay did not have enough players at U12. They come to us and say we're taking a Leave of Absence. Whether they've gone to the NOHA and told you that or not, there's no team, so to make the comment that you've got

It's just, and what I'm getting at is if I was on your side sitting on the NOHA Board, you're picking winners and losers, and I wouldn't want to be in that position because there are a lot of people who have done a lot of hard work, and you guys actually don't go to the rinks and see those kids play. Some of those kids are playing really hard, we have really good coaches, we're developing players, and then we put in the application, it comes to the Board, and it's denied. Over the last couple of years we've had, in the north where we're from, we've had some associations that chose not to go to a playoff format because they weren't as strong as the other teams, and the host towns, it really put them in a bad spot because there was a limited amount of teams. As an example, two years ago at U15, the league playoffs were supposed to be in Chapleau, it was only going to be three teams, but one team pulled out and left it to two. They ended up having to cancel those playoffs, and it was pretty big for the town of Chapleau because they booked some ice, people were staying in their hotels, eating in their restaurants, so it made, there were certain associations that kind of picked and choose where they wanted to go, they didn't want to go to Chapleau because they were going to kind of get their butts handed to them. In the same breath, that's the same association that wanted you to go to their place because they wanted ice rentals and hotel rooms and restaurants, so this goes on lots, and this needs to go through to stop associations from doing this. Thanks.

11.2 Representative Tournament of Champions

11.2.1 Host Selection

- a) The Tournament of Champions will be held in the month of March and April and the dates will be determined by the NOHA Board of Directors.
- b) Requests to host will be received by the Executive Director until October 1st. The total number of entries eligible to attend will be confirmed by December 31st of the current season.
- c) All Associations/Single Entry Teams shall be eligible to host a Tournament of Champions. Associations may apply for a higher category to which they are registered.
- d) All NOHA U11 to U18 AA-C category playoffs will be in a Tournament of Champions format where sufficient entries permit. All Teams participating will be guaranteed a minimum of four games in the tournament format. Where there are not enough Teams available for a Championship, Minor Teams may request to the NOHA Board the ability to play in the Major Division of a Tournament of Champions.
- e) Where there are only two Teams registered for a Tournament of Championships this championship will not be held unless the Championship requires the declaration of a winner to send to an OHF Championship, in which case the winner shall be declared in the method as determined by the NOHA Board of Directors.
- f) If an Association has been awarded to host an NOHA Tournament of Champions, they must declare, in writing, by October 31st if they are unable to register a Team.
- g) No NOHA Team may apply to host an Ontario Hockey Federation

11.2.2 Team Selection

- a) Notwithstanding Teams who participate in the same League in accordance with R.11.4.d), participation in the Tournament of Champions is optional. Teams who want to participate must send their application and applicable fees to the NOHA Office by December 1st. If application fees are not received at the NOHA Office by December 1st, then the NOHA will invoice the Association for the Tournament of Champions registration fee plus \$50.00. After December 1st, the NOHA will only accept additional entries upon consultation with the Host Association and with the NOHA Board of Directors.
- b) Where Associations have more than one (1) Team per Division, they may apply to attend the Tournament of Champions. The NOHA Playoff Committee will determine, based on the number of registrations for the Division, whether they can accept multiple Teams from the same Association. Where additional entries cannot be accepted, the Association will be notified by December 31st and they will be responsible to identify which Team will attend.
- c) Teams who apply for a change of category for the Tournament of Champions may be moved to a Category other than the one requested at the discretion of the NOHA Board.
 - 11.2.3 No Tournament of Champions will have more than ten (10) Teams. Fees
- a) The NOHA Playoff Committee shall recommend to the NOHA Board of Directors the registration fee for the Tournament of Champions.

11.2.4 Withdrawal from Tournament of Champions

- a) Any team withdrawing from the Tournament of Champions after the deadline shall forfeit their monies to the NOHA.
- b) Any team, in the opinion of the NOHA Board of Directors, which fails to fulfill its obligation in any league playoffs or NOHA Tournament of Champions during any season shall be refused entry in the NOHA for the following season and all players registered with said team shall be declared free agents.

11.2.5 Schedule and Games

a) Scheduling of NOHA Playoffs may not be done until the participant Teams are properly seeded by the host committee and approved by the NOHA Playoff Committee. Through scheduling, every effort must be made to allow each team the chance to compete against Teams from other Leagues while attending the TOC. Teams travelling the farthest distance shall be scheduled as late as possible in accordance with the schedule

- c) Selected Teams must submit to the NOHA Office their roster no later than January 31st. If a Team withdraws from the Tournament of Champions after notification of acceptance the Team will forfeit its registration fees.

11.4 League Playoffs

- a) In U18 "AAA" hockey, a playoff schedule will be set by the Great North U18 League with the approval of the NOHA Board of Directors, prior to the start of the season, to determine the NOHA Champion.
- b) In U15 "AAA" hockey, a playoff schedule will be set by the Northern Ontario AAA Hockey League with the approval of the NOHA Board of Directors, prior to the start of the season, to determine the NOHA Champion.
- c) In U13 "AAA" hockey, a playoff schedule will be set by the Northern Ontario AAA Hockey League with the approval of the NOHA Board of Directors, prior to the start of the season, to determine the NOHA Champion.
- d) Where all Teams in an age division are competing within the same League, the NOHA
 - Tournament of Champions shall be the League Championship.
- d) In order to qualify for the NOHA playoffs, all AAA Teams in all AAA Divisions must play in a AAA NOHA League (where a properly sanctioned AAA league exists) or three or more Teams in the same Division.

 "AAA" Teams may play in a League of a higher Division.

 In all Leagues in U21, U18, U15, U13 and U11, in the same category, there must be a league playoff to declare a league winner in order to compete in the NOHA playoffs unless the league, with the approval of all teams, files its method of selecting a winner with the NOHA Executive Director.
- e) Any Teams requesting outside Officials after the commencement of any

12.1 Tournament Hosting

- a) A Tournament sanction permit will be issued only to the Minor Hockey Association. The sanction fees, a copy of the Tournament rules, and a copy of the invitation must accompany the application into the NOHA Office 60 days prior to the Tournament.
- b) A list of Teams that are entering the Tournament must be forwarded to the NOHA Office and the District Council Director fourteen (14) days prior to the start of the tournament. The completed schedule can then be e-mailed when the final draft is ready to be sent to all Teams. All Tournaments (House

League and Representative) are required to submit a Tournament reconciliation to the NOHA Office sixty (60) days after the completion of the Tournament. Tournament hosts must also submit all game sheets, Tournament permits, final game schedule and HCR approved rosters to the NOHA Office with their reconciliation. All Tournaments are required to check the HCR approved rosters of each Team participating to verify their eligibility.

Once everything has been submitted, the NOHA Office will inform the Association of any missing documents and assistance will be provided to the Association to secure the required documents, where possible.

- c) If a sanctioned Tournament changes anything on the application that has already been approved, they must send the revised invitation and rules and regulations to all Teams that have applied to notify them of the changes and allow them to withdraw with no penalty imposed.
- d) No entry shall be accepted from any Team of any OHF Member, another HC Member, IIHF, or USA Hockey without an approved Tournament permit from their governing organization. The written permission must be presented upon registration at the tournament for inspection by the NOHA Board Member or Tournament Committee member and mailed to the NOHA Office with the Tournament reconciliation.
- e) A Tournament sanction may be withdrawn from any Association that accepts entries from a Team, or Players, that are under suspension or are not approved by the NOHA or any other OHF, HC, or IIHF Member.
- f) A copy of the Tournament rules and regulations and schedule shall be given in writing by the host to all Teams before commencing play.
- g) When Teams or Players are required to play three (3) Tournament games in one day at U10 and above, there shall be a minimum of three (3) hours between the finish of one game and the start of the next game.
- h) No cash prizes or cash awards are to be given to any Team or individual Player in any sanctioned NOHA Minor Hockey Tournament.
- i) Any permit sanctioning a tournament by the NOHA may be withdrawn if it is found that Hockey Canada, OHF or NOHA regulations pertaining to such Tournaments are not followed.
 - Subsequent permits may not be issued to any Association who has been found to have conducted a sanctioned Tournament which has not followed Hockey Canada, OHF or NOHA Regulations.
- j) All sanctioned Tournaments will be played only under official Hockey Canada playing rules. Should there be any variance from such rules, they shall be submitted at the time of application for a sanction permit.
